### Central Air Conditioner\*

SEER2 15 - Replacing Failed or Operating Equipment (15.2 - 15.99)	\$400
SEER2 16 - Replacing Failed or Operating Equipment (16-16.99)	\$500
SEER2 17+ - Replacing Failed or Operating Equipment (17-40)	\$600

### Heat Pump Mini-Splits\*

Heat Pump Mini-Split - Replacing Operating or New Add to Any System	\$150
Heat Pump Mini-Split - Replacing Failed Mini-Split or New Construction Addition	\$150

### Ground Source Heat Pump (GSHP)\*

Replacing Failed GSHP, ASHP, Air Conditioner with Electric Resistance Furnace	\$1,000
New Installation (no previous equipment)	\$1,000
Replacing Operating GSHP, ASHP, Air Conditioner with Electric Resistance Furnace	\$1,500

Duct Sealing	Up to 50% of cost	\$250
Insulation Rim/Band Joist	Minimum 50 linear feet covered	\$50

Rebates valid for measures installed on or after June 1, 2024, for Everygy Kansas customers. Rebates are valid based on the following: central air conditioner rebates are valid for existing air conditioner replacement; heat pump rebates are valid for existing heat pump or electric resistance heat replacement.

\*All systems are required to be Air-Conditioning, Heating and Refrigeration Institute (AHRI) certified at the SEER2 ratings as shown above. SEER2 ratings and certification require installation of a matching coil and may require installation of a new furnace or air handler. Ask your contractor for details.

\*Maximum Incentive = Maximum payout per measure for Kansas Energy Efficiency Investment Act 1 (KEEIA) term until December 31, 2027.
